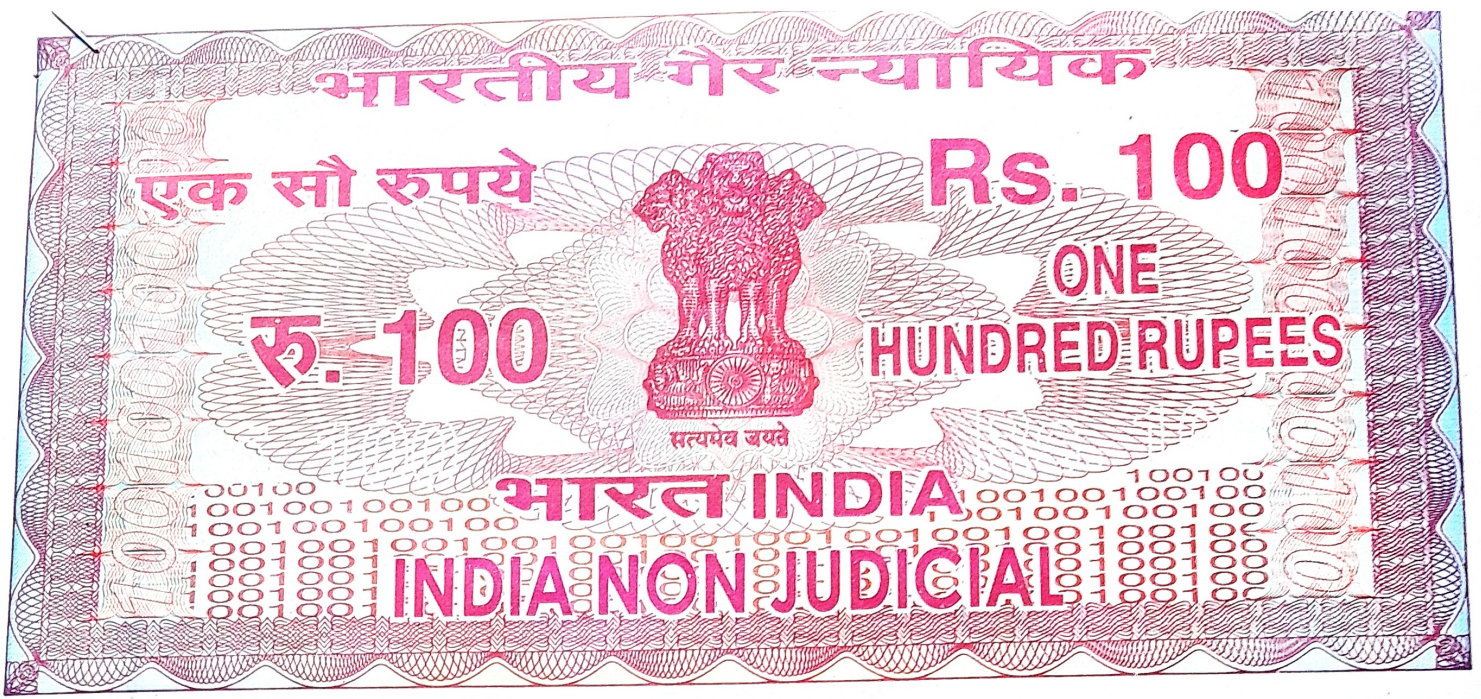

## WHEREAS

B) Ceasura Technologies, Chennai- 600 091. - The Second Party is engaged in Software development.

### CLAUSE 1: CO-OPERATION

### CLAUSE 3: VALIDITY

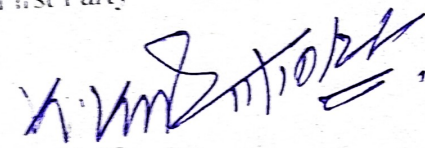
3.1 This Agreement will be valid for a period of three years and can be terminated by either Party on one month written notice without affecting ongoing commitments.

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.

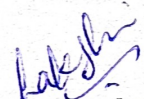

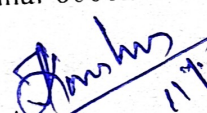
