MEMORANDUM OF UNDERSTANDING
BETWEEN
INSPIRE SOFTECH SOLUTIONS, CHENNAI
AND
NATIONAL COLLEGE (AUTONOMOUS), TRICHY

This Memorandum of Understanding (MoU) is executed on this 11th day of April 2023 between INSPIRE SOFTECH SOLUTIONS, a company functioning at No.170/31, Rojathottam First Cross Street, East Tambaram, Chennai – 600 059, India, hereinafter called INSPIRE SOFTECH SOLUTIONS which expression shall where the context so admits include its successors and permitted assigns as one part and NATIONAL COLLEGE (AUTONOMOUS), herein after referred to as NCT, located at No:53, Violet College Road, Menambedu, Chennai – 600053, represented by The Principal, which expression shall include its successors, legal heirs and assigns on the other part.

After studying the strengths and objectives, **INSPIRE SOFTECH SOLUTIONS** and **NCT**, agreed that they can share the expertise available at both ends for mutual benefits in the field of education, training, scientific and industrial research and enter in MoU. Based on the discussion held among the faculty of the **DEPARTMENT OF COMPUTER APPLICATIONS** of **NCT** certain thematic areas/programmes have been identified for mutual collaboration.

The Memorandum of Understanding envisages the following:

I. Collaborative technical and development activities in the fields of education and training will be carried out between INSPIRE SOFTECH SOLUTIONS and the DEPARTMENT OF COMPUTER APPLICATIONS of NCT in

- a) Consultancy work
- b) Internship cum placement training.
- c) Research assistance to faculty members and research Scholars
- d) Imparting training to faculty on emerging areas.
- e) Providing opportunity to students to work with the technology available.
- f) Resource Sharing, i.e. students exchange and faculty exchange activities.

II. Industrial visits and project work for the students are to be carried out at INSPIRE SOFTECH SOLUTIONS, if the training projects and infra-structure facilities available at INSPIRE SOFTECH SOLUTIONS fit the requirements of the students of NCT.

VI. No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this MOU. The modification/changes shall be effective from the date on which they are made or executed, unless otherwise agree to.

VII. The duration of this MOU shall be for 2 years from the date of signing of the MOU. The MOU shall stand renewed automatically unless desired otherwise by either party. This MOU shall be terminated for no cause by giving six months advance written notice by either of the parties.
